1. Thank you for returning my call this morning, just to document our query on the required ICC for the above mentioned Bidding, may we clarify if we also need to secure a BID BOND for this?

Insurer Clearance Certification (ICC) is normally free to secure at the Department of Commerce while a Bid Bond needs a premium to be paid to our insurance company.

Answer (“A”): Section III(C)(2)(a)(1) of RFP-2026-JUD-8/VSS Bid No. 42600113 states that the Contractor shall furnish (i) a Payment Bond of one hundred percent (100%), and (ii) a Performance Bond of one hundred percent (100%) of the total proposal price must be submitted to the Judiciary on the day of the execution of the contract. Additionally, Section III(C)(2)(a)(2) states that the Contractor shall submit the Insurer Clearance Certification at the same time payment and performance bonds are furnished.

¹ The request for information questionnaires was provided by prospective proposer(s). The Judiciary retained the exact language from the questionnaires without modifying its grammar or spelling.
