1. Copy of site layout in CAD and PDF format

Answer ("A"): The Judiciary does not have a site layout in Computer-Aided Design (CAD) format. A Portable Document Format (PDF) detailing camera replacement is provided in Appendix A.

2. Clarification, if the testers to be used must have current factory certification.

A: The certified cable analyzer does not need to have a current factory certification, but the model used must meet TIA/EIA-568 standards.

3. Clarification, if the technician must have current network certification to test and certify the cables.

A: The RFP does not require a technician with current network certification to test and certify the cables, but the electronic test reports for cable testing must provide passing results based on TIA/EIA-568 standards through a certified cable analyzer.

4. May I kindly request a copy of the as-built plan for Kotten Tinian?

A: The Judiciary does not have a current as-built plan. A PDF detailing camera replacements and new installations is provided in Appendix A.
